

## U.S. Data Subject Action Request Form

### Generally

Residents of some jurisdictions in the United States have certain data privacy rights (referred to as “Data Subjects(s)” in this form) as more fully described below.

The personal information required by this form is necessary to enable Skydance Productions, LLC and its parent, subsidiaries, and other affiliates under the control of our corporate parent (“Skydance”) to process your Data Subject Action Request made in any capacity. The information you supply will only be used for the purposes of identifying the personal information you are requesting and for responding to your request and maintaining related records. To protect data subject data privacy and security, for most requests (i.e., other than certain opt-outs) we will need to verify your identity, and we will not collect personal information when we do not already have to do so. Promptly provide us any additional information we request to identify the data subject and, if applicable, verify the authority of an agent. If we are unable to verify identity and/or authority to the requisite level of certainty, we will deny the request. **DO NOT** send any sensitive personal information, including social security numbers or copies of government IDs.

We are only obligated to process rights requests of California and Texas (and Nebraska, starting January 1, 2025) residents. Nevada residents only have a “Do Not Sell” right that they may effectuate through this form in 5.A., below. We will apply the laws of the state where you are a resident to your request. For residents of states without applicable consumer privacy laws, or where we are not subject to a state’s jurisdiction (e.g., we do not meet applicability thresholds), we will consider requests but will apply our discretion with respect to and if and how we process such requests. We will consider applying state law rights prior to the effective date of such laws but will do so in our discretion. We only accept requests in the context of personnel and business contacts from California residents.
